1. Organization/Individual: _____ (hereafter "Performer(s)") is applying for permission to use a space or spaces on the grounds of City of Oceanside, Umeke event, between the designated hours for setup, selling, and teardown. In the performance of this contract, "Vendor" and the agents and employees of "Vendor" shall act in an independent capacity and not as officers or employees or agents of Umeke.
 2. "Performer(s)" agrees to indemnify, defend and hold harmless the Umeke, its officers, agents, volunteers and/or employees against and from any and all claims, demands, lawsuits, damages, liability or loss, expenses and costs, in law or in equity, from any cause whatever, including the negligence (active or passive) of the Event venue and Umeke property and equipment, its officers, agents or employees, arising from the use of the facilities or activities in and about the same by Vendor or their representatives or invitees. This is to include those brought for, or on account of damage or loss of any item in Vendor's space or injuries to or death of any person or persons, including "Performer(s)," or damage to or in connection with the specified event. The intent of this indemnity agreement is to avoid any responsibility on the part of Umeke and its agents from paying money for the defense of any lawsuit or claim, or any settlement or verdict.
 3. "Performer(s)" acknowledges that this is a "Rain or Shine" event.
 4. Any and all artwork and logo materials created for Umeke are the sole property of Umeke and may not be reproduced without permission.
 5. "Performer(s)" shall leave the venue/facilities in a clean and orderly condition. No alterations of any type may be made to the buildings or premises, particularly the outside surface of any buildings, without the express written authorization of Umeke. As an example, the use of thumbtacks, nails or tape on walls, light posts, fences or buildings is not permitted, as it damages the property. "Performer(s)" agrees to assume responsibility for any damages done to the venue/premises or buildings caused by any of your guests or attendees. If any alterations were allowed, "Performer(s)" agrees to restore the facilities to their original condition; and shall repair any damage arising out of the use of the facilities under this agreement. Should any damage occur during your use of the premises and facilities as described in this agreement and "Performer(s)" refuses to pay for the cost of repairs, "Performer(s)" agrees to submit the matter to binding arbitration according to the rules of the American Arbitration Association. The prevailing party is entitled to their legal fees.
